LEGAL DISCLAIMER, RELEASE FROM LIABILITY & TERMS OF SERVICE:

Please read this information carefully:

By scheduling and requesting any service offered, communicating with Rose Ann Kulyk (herein after may be referred to as Rose), and/or paying for any Services, Parties, Events, Classes or Workshops Rose Ann Kulyk offers, you are stating that you have read this Legal Disclaimer, Release From Liability (hereinafter referred to as "Release") and the Terms of Service and that you understand and willingly enter into, agree with, and accept ALL that is shared herein:

1. You are 18 years of age or older or you are accompanied and/or have signed approval from a legal guardian.
2. 100% accuracy cannot be guaranteed. By its very nature, working with Spirit and with psychic energy requires the participation of at least one human and humans are imperfect creatures. 4. Fees for services must be received prior to your scheduled session or unless otherwise stated (for example a workshop or class may require specific protocol). There are times now that many are pre-paying for sessions especially if the session is booked far in advance or Rose is guided to ask for pre-payment, (packages and programs have their own protocol). Money orders and cash (at your own risk, if mailing) and PayPal, Credit Card Via phone or in person, E-Transfer, and now Debit are the most preferred methods of payment. If you are scheduled for an in-person session, you may bring your payment to your appointment, in some cases a deposit is required to hold the spot you have requested. Should you need to cancel your scheduled service or should Rose Ann Kulyk need to cancel your scheduled service, you will be offered the option of rescheduling that service, if you cancel within the guideline of the cancellation policy and your deposit will be used for that appointment unless otherwise stated when deposit is made/ if you do not cancel within the guidelines of the cancellation policy (within 48 hours for services / 2 weeks for events,

workshops and classes) the deposit will be kept and / OR FULL Payment for the amount of time requested when booking the appointment. If your scheduled service is not rescheduled any payment received will be promptly refunded when you follow the required agreement to the cancellation policy that is listed below and on this site.

5. When cancelling an appointment, we require a 48 hour cancellation notice (unless otherwise agreed upon due to circumstances beyond ones control). Events, Classes and Workshops require a 2 week notice for any refunds to be given. If cancellation time is not provided, charges for the full service(s) and or deposit for the Service/Party/Event/Workshop/Class will not be refunded and or applied to the gift certificate used to hold the appointment. If appropriate cancellation time is provided the deposit (or a portion of it depending on the agreement when made) can either be promptly refunded to you or applied to a rescheduled appointment and or upcoming event, class or workshop. If you are late for the session and there is not any good reason and / or it interferes with Rose's work with others, you will be charged fully for the time set aside to work with you aside from the work we are doing together.

6. Rose is a conscious channel and when she is working with you she is so **focused on YOU and YOUR issue THAT TIME CAN PASS BY QUICKLY!** One hour can feel like just a few minutes. Rose's work has grown over time and some of her sessions may go well beyond the time you requested.

YOUR ASSISTANCE IS NEEDED: If you have a certain budget it is very important that you assist Rose by keeping the time for yourself as well! There is a clock in the room and you can use a timer to assist in making sure that the time you requested does not go over. Sometimes she may be so focused on assisting you that she may lose track of time herself. This is why she charges by her time. At present those fees are \$75.00 for a half hour and \$125.00 per hour and approximately \$2.10 per minute thereafter.

7. Recordings: Rose will be recording during consultations and your session while working with you. These files are the property of Rose Ann Kulyk and for SECURITY and record keeping. If you want a recording of your session you can bring a recording device yourself to the session. **NOTE TO PREVIOUS CLIENTS:** Recordings of a session offered previously were offered as a courtesy and would be made available to you for **up to 2 weeks after the session. When sending via Drop Box they are there for 2 weeks and deleted and when sending via WeTransfer the link lasts for 7 days from the date sent!** After which they are the property of Rose Ann Kulyk and if requested to be sent after this window of time. **FULL PAYMENT** for the session is required (If a discount was given as a result of your decline of the offer of the files) and an administration fee will be charged (at present it is a \$25.00 fee and the balance of any discount offered). At which time these files are STILL the property of Rose Ann Kulyk. At this point it is up to the discretion of Rose Ann Kulyk if she so chooses to accommodate your request and an administration fee of (\$25.00 at present) may be requested before those files would be sent as per your request.
